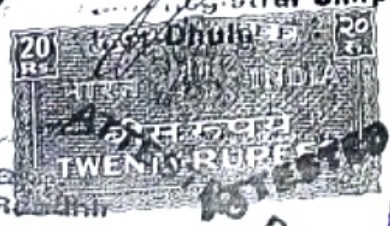

7) **Members :-** The members of the institution will be as follows - The members of the institution will be called as general members for the same the following rules will be applied.

- 1) He must have completed 18 years of his age.
- 2) He must remit Rs. 2001 only (Two Thousand One only) in the beginning.
- 3) In each financial year, the member must pay Rs. 101 before 31<sup>st</sup> March, as member fees.
- 4) As per the register of the institution, 31<sup>st</sup> March 1994, the registered person from different categories will be called as the general members of the Sanstha, subject to the condition such member should pay his membership fees Rs. 101/- every financial year. Such membership fees would be paid for further financial year, if he fails to pay the fees, his membership will be cancelled without any prior instruction, the right is preserved by the management.
- 5) The management has reserved the right to accept membership, to refuse membership or/and to cancel the membership. No complaint will be registered against the right of the management.

8) **Members and there registration sistem :-**

Any person, 18 year old permitted to be member of Sanstha, for that he has to apply for the same.

9) **Cancellation of Membership :-**

The membership of the members of the institution will be cancelled on the following basis.

1). Membership of the member will be automatically cancelled after his death.

2) The membership of the member will be cancelled if the behaviour of the member is against the aims and
